#### SHOW GUIDELINES

- 1 A \$30 fee will be assessed for all returned checks.
- 2 Pets **are not** permitted at the Plant City Fairgrounds.
- 3 Food vendors are to follow all health department rules and regulations.
- 4 Booths must be open and staffed during the shows at all times. Booths **are not** to be dismantled earlier than 4 pm without show management approval. **All vehicles must be removed from show area prior to show opening and not returned to area until show ends.**
- 5 Vendors must keep their areas clean and neat during market hours, including final clean up at the end of the day. **The Fancy Flea Vintage Home & Garden Market LLC** will not be responsible for refunds or any liabilities for the failure to fulfill this contract due to the location of the show being destroyed by fire or other calamity, or by any Act of God, public enemy, strikes, ordinances, or any legal authority, or any cause beyond its control. **Show is held rain or shine. No refunds for cancellations 60 days prior to the show date.**
- 6 Vendors shall be liable for delivery, handling, erection/removal of their display and materials. Vendors found in violation of these rules may be excluded from future shows at management's sole discretion. No refunds will be provided. Under no circumstances (including negligence) shall **The Fancy Flea Vintage Home & Garden Market LLC** be liable for any direct, indirect, incidental, special or consequential damages resulting from such action.
- 7 This agreement constitutes a contract between **The Fancy Flea Vintage Home & Garden Market LLC** and the vendor and modifications are invalid unless in writing and approved by show management.
- 8 Failure to follow these rules or exhibiting crude or abusive behavior will result in termination of your involvement in future shows.
- 9 Tents are recommended in case of inclement weather. **No vehicles or trailers are permitted in the show area once the show opens.** Please bring plastic tarps or coverings for your item's protection in case of bad weather.
- 10 **SET UP** is Thursday, 8 am - 4 pm (no admission after 3:30 pm) and Friday, 6 am - 8:30 am. **Vehicles MUST be removed from show area 30 minutes prior to show start.**
